Mike,

Please see the attached spreadsheet that shows where our invoices are in processing. We have been paid for # 's 4 and 5 on that spreadsheet which are the first 2 from the 2023 Niagara Sailing Services Contract.

Settlement Agreement # 2 which is for all expenses from 4/24/23 - 7/30/23 was sent to us on Thursday. This means the 150 days clock will start when I sign it. I will be back in my office on Wednesday and will do so.

All invoices have been submitted to PHMC. There will be some November expenses that will go into the next invoice but we are as up to date as we can be.

We did submit a claim for when the prop fell off. The amount was ~\$6k. It is not in our best interest to have that claim history for such a small amount of money so we have not received it. Furthermore we would have to give that money to PHMC once they replace that prop.

I have reached out to Pat Harkins again to inform him of where we stand with our payments. Hopefully he can help out. When discussing our invoices earlier in the Fall with Jim the expectation is that PHMC would expedite the settlement agreements which could have hopefully gotten us paid in December. They have not done that. It now looks like May or June for payment. That is not good for the League. Even with ECGRA and the annual appeal I feel we will need to lay off all junior staff and bring senior staff to half time 1 week from today. If you would like to meet to discuss this in advance of the board retreat I can schedule a meeting or we can discuss then.
